Course Description

This course introduces you to the theory and practice of investments, covering the topic areas of capital market structure, valuation, security analysis, portfolio management, and investor psychology. The course is designed to develop a theoretical framework for investing and to provide the student with some practice in applying that framework to typical investment decision-making.

Course Objectives

Below are our key course objectives:

- Understand the fundamental concepts of investing
- Understand various asset classes, primarily equity and fixed income
- Understand stock and bond valuation
- Become aware about the behavioral and psychological aspects of investing
- Apply the knowledge gained towards rendering an investment decision on a stock

Course Material

The suggested text is *Investments: Analysis and Behavior*, by Mark Hirschey and John Nofsinger, 2nd edition. Alongside power-point slides, I have also posted pdfs of the relevant materials for various chapters on Canvas. If you want to acquire a hard copy of the textbook and save money, you could consider the first edition or an international edition (consider expedited shipping if you are buying from an international seller). A copy of the text is available at the Course Reserves in the Milner Library.

Please invest in a *financial calculator*, which you should bring to every class and to all exams. I recommend the TI-BA II Plus, and will provide support for it during class. Also, subscribing to *Wall Street Journal/Financial Times* or any other financial press will keep you informed of the latest news about the economy and stock markets.

The Canvas course website (<https://canvas.illinoisstate.edu/>) will be the primary mode of communication outside of the classroom and you should log in a regular basis. I have organized your course material into 6 modules. The course schedule mentions the chapter covered under each module. Each module will contain relevant power-point slides, short videos, and suggested end of chapter problems.

Class format

This class will be delivered in a hybrid format. We will typically meet once a week on Mondays in person. Please refer to my updated tentative schedule for details. During our in-person sessions, I will review some key materials and answer any questions you may have. On the days that we do not meet in person, you are expected to self-study, review materials and take your tests (quizzes/exams) online. Please note that all testing and submissions will occur online. To access your course materials, please lookup Modules on Canvas.

Instructor's Statements

The key to gaining a good understanding of the course material is to pay attention in class and stay current with the readings during the self-study days. Also, please solve the suggested practice problems assigned for each chapter. Attendance in class is essential unless you are sick. If you are unable to attend a class, it is your responsibility to ensure that you stay current with the material.

My power-point slides posted online condense the material in the textbook to help focus on testable parts of each chapter. Only the topics covered in power-point slides are testable. In addition, I will also provide you short video lectures to discuss some important topics and examples.

I request you to closely track the deadlines stated on the tentative course schedule. If needed, I will notify you about any revisions to the course schedule. To provide you considerable flexibility, your quizzes and exams will remain open for about 1 ½ days. For more details, please reference your course schedule.

I will be available during my Zoom virtual office hours to help you. If needed, you can schedule an in-person meeting with me as well. I look forward to working with you and contributing to your academic and future professional success.

Participation and Attendance

A portion of your grade will be related to class attendance and participation in class discussions, which includes asking questions of the professor. Keep in mind that class attendance \neq discussion participation. You are strongly encouraged to speak up when you have questions. When assigning your participation grade, I will place heavy emphasis on your active participation in discussions.

Participation points also include general assignments or concept check quizzes for any assigned material. You will be awarded full credit as long as you meet the minimum passing requirement on these. In addition, a portion of your participation scores may include points towards participating in a short assurance of learning quiz that you may be required to take towards the end of the semester. Please note that this quiz is not specific to this course and is required towards assessment of learning for all students taking FIL 242 in the College of Business.

Grading

Your course grade will be based on quizzes, exams, a stock selection project, and class participation.

All testing (quizzes and exams) for this course will be online (using either the Respondus LockDown browser or Proctortrak). There will be four quizzes during the semester, each covering a specific learning module. The best of 3 quizzes will be taken for calculating your final grades. Please refer to the schedule for details on the materials covered for each quiz. Each quiz will have about 20 multiple choice questions with a time limit of 40 to 50 mins approx. The quizzes will help you stay current with the course material, know your weaknesses and help you prepare you for exams. There will be two exams during the semester, each covering three learning modules. Exam 1 will cover material in learning modules 1 to 3. Exam 2 will cover material in learning modules 4 to 6. Each exam will have about 40 multiple choice questions with a time limit of 1 hr 30 mins (90 mins) to 2 hrs (120 mins) approx.

You will be allowed only a single attempt for the quizzes and exams. To access them, please click on the "Quizzes" tab in Canvas on the dates specified in your course schedule. I have setup up special questions banks, to ensure that none of your tests are not identical. The tests have been designed to ensure that all students are tested on the same topics and at the same difficulty levels. We will be using **either the Respondus LockDown browser or Proctortrak** for testing. I will keep you informed via Canvas.

Stock Selection Project

This project involves selecting a stock and applying the material you learn during this semester to prepare a brief stock report. The project will be implemented in three phases. Phase I involves selecting a stock at the beginning of the semester. In Phase II you will be required to do some analysis using MS Excel. Phase III, which is due towards the end of the semester, consists of preparing a report on the selected stock. The stock selection project has an 8 percent weight in your final grade and the weights allocation for Phase I, Phase II and Phase III are 2, 2 and 4 percent, respectively. I will be posting specific guidelines for the project separately and will discuss further details in class. *Any submission made beyond the submission deadline will not be eligible for any credit and will result in a zero.*
