Course Format:

- Asynchronous lectures and online learning activities: The presentation of the course material will be delivered on Canvas. Students are required to pre-study the online material prior to an in-person class and finish the associated activities from the worksheet. It is crucial that you keep up with these activities in order to be successful in this class.

Lecture videos for each chapter are created. All videos are available on Canvas under "Files" at the beginning of the course period. For each chapter, you will find lecture videos and a worksheet. You will receive the worksheet in class, but you are welcome to print the worksheet for additional practice. Please take notes on the worksheet and practice the problems while watching the videos.

Course Objectives:

The objective of the course is to study the theory and empirical evidence relevant for investing. The major topics include:

- . Overview of capital markets
- . Optimal portfolio selection
- . The relation between risk and return
- . Delegated portfolio management and performance evaluation
- . Fixed income securities
- . Derivative markets (time permitting)

Class Materials:

Textbook: Bodie, Kane, and Marcus: *Essentials of Investments*, 9th edition, McGraw-Hill. (Referred to as **BKM** hereafter)

Calculator:

You need a **financial calculator** for this class. Please bring your financial calculator to every class for in-class exercises. (Texas Instruments BAII Plus recommended)

Practice Problems:

Some of the end-of-chapter problems in our textbook will be recommended as practice problems. Solutions to these problems will be provided. Your work on the practice problems will not be collected or graded, but it should help you to prepare for the exams.

Homework Assignments:

There will be five homework assignments with due dates specified in the syllabus. Solutions to homework problems will be released 24 hours after the due date.

All homework assignments are available on Canvas under "Quizzes" at the beginning of the semester. It will remain open until 11:55 pm on the due date. You can access and submit the assignment at any time before 11:55 pm on the due date. Once the assignment is due, you will no longer have access to it, nor will you be able to submit it. Since you can access and submit each assignment online at your convenience, late homework will not be accepted.

Exams:

There will be three exams. Exam 1 will be administered during class. Exam 2 and the final exam will be delivered online via Canvas.

Exams are given on specified dates. *There will be no makeup exams unless appropriate documents are provided to justify the absence.* For valid reasons (illness, school-sponsored activities, and job interviews are the only valid reasons), makeup exams will be given. **Proof is required when scheduling makeup exams.** It is the student's responsibility to notify me **BEFORE** the exam if a makeup exam is necessary. It is also the student's responsibility to schedule a time with me to take the exam no more than three days following the exam. A make-up exam will be substantially modified from that given to the rest of the class. The exams will be given on the following days:
